

Survey type	Public opinion quantitative survey in Poros and Methana
Sample	Men and women, 17 years old and above
Sample size and coverage	602 respondents, residents of Poros (402) and Methana (200)
Data collection period	3 – 8 July 2023
Sampling	Multistage sampling using quotas with respect to geographical distribution, gender, and age of the local population based on the 2011 census of the Hellenic Statistical Authority (ELSTAT). Data are weighted by gender and age
Data collection method	Interviews were conducted as follows: 63% (378 interviews) via telephone calls (CATI) and 37% (224 interviews) through a digital questionnaire (CAWI) following a targeted internet campaign
Error and rounding	Standard error of 4% with a confidence interval of 95%. Results (%) are rounded to 1% and responses may not add up to 100%


AQUACULTURE AND FISH FARMING AWARENESS LEVEL

How familiar would you say you are with aquaculture and fish farming?




NATIONAL FISH FARM EXPANSION PLAN AWARENESS LEVEL

More specifically, are you aware of the plans for the expansion of fish farms on Poros?




DEGREE OF AGREEMENT WITH THE NATIONAL FISH FARM EXPANSION PLAN

Do you personally agree or disagree with the plans to expand fish farms in Greece?




DEGREE OF AGREEMENT WITH THE FISH FARM EXPANSION PLAN ON POROS

Which of the following best expresses your feelings about the plans to expand fish farms on Poros?




If fish farms are expanded on Poros, in your opinion how will this affect each of the following aspects in the place you live? (Please respond for each aspect separately)
